CONTRACT FOR RESERVATION AND PERPETUAL CARE  
Of a NICHE contained in the Memorial Garden of White Plains United Methodist Church

This contract made and entered into the \_\_\_\_ day of \_\_\_\_\_, 20\_\_, by and between White Plains United Methodist Church, Inc., hereafter referred to as the "Church", and \_\_\_\_\_, here after referred to as "Reserver.

Whereas, the Church has designated a plot of land on its premises known as the "Memorial Garden" which contains a columbarium that is set aside as a repository for the cremated ashes of eligible persons;

Whereas, the Church has established a Memorial Garden Policy and Procedures document, =hereafter referred to as "Policy", the document attached hereto and made a part hereof, governing eligibility and use of the Memorial Garden columbarium;

Whereas, the Church desires to sell and Reserver desires to reserve the use of a niche in the columbarium.

Therefore, the parties hereby agree as follows:

1. The Church agrees to provide to Reserver and Reserver agrees to pay for the use of a niche in the Memorial Garden columbarium for the cremated remains of one or two persons.
2. The Church agrees to have the niche cover inscribed with the name, date of birth, date of death of the persons to be inured therein and other text as contained in this document and to provide perpetual care.
3. The Church shall retain full title to the columbarium niche and hereby grants to Reserver only the right to the use of one niche, in according to the Policy.
4. Reserver has read the Policy, is familiar with the contents thereof and agrees to be bound by the Policy. Reserver further agrees to any future changes that may be made to the Policy.
5. Reserver authorizes the Church to relocate the Memorial Garden, his/her niche and the cremated remains therein to another proper location should it become necessary for any reason, and this authorization shall be binding upon his/her heirs, executors, administrators and assigns.
6. Reserver warrants that he/she has all right, title and interest in and to the mortal remains of the persons anticipated to be interred at the Memorial Garden and further warrants that he/she has full right and authority to execute this contract. The Church has and assumes no responsibility to inquire further into the authority of the persons executing this contract.
